Compensation Procedure for Online Instruction

I. Overview

The purpose of this procedure is to identify the compensation process for compensating a faculty member teaching an online course. Courses utilizing the Internet as a supplementary instructional tool do not fall under this procedure.

II. Practice

- 1. The course will be treated as a part of the regular teaching load of the faculty member. Overload pay will be available if the faculty member is teaching a load that qualifies for overload pay. Faculty teaching the usual credit hour load, including an online course in this total, will not be eligible for overload pay.
- 2. The Director of Educational Technology shall maintain a record of who will teach online courses in an upcoming semester and will make certain that the faculty member has the appropriate paperwork processed to ensure payment, if warranted.
- 3. All full-time faculty overloads must have Division Chair approval. At the beginning of each semester, the Director of Educational Technology will provide a schedule of faculty appointments, with compensation at the adjunct/overload pay rate. Personnel Action Forms (PAF) for the appointments will be submitted to the Vice Chancellor for Academics. These PAFs will be processed according to UACCB policy.
- 4. To provide greater efficiencies and value to students, faculty, and the institution, a "high-capacity" classification of online classes is established. High-capacity online classes will
 - a. Adhere to minimum class size for load and compensation as established in Procedure 406.6, Compensation Procedure for Faculty Teaching Low Enrollment Courses.
 - b. Count toward load and overload as the equivalent course taught with traditional limits.
 - i. Unless noted below, the traditional class size limit is 30-35 students depending on room capacity.
 - 1. The class limit for composition and literature classes requiring significant grading of papers is 25 students.
 - 2. The class limit for developmental education classes is 20 students.
 - c. Be capped at a maximum of 64 students.
- 5. Compensation for "high-capacity" is as follows:
 - a. Student enrollments 1-10 \$160 per student
 - b. Student enrollments 11-27 No additional pay
 - c. Student enrollments 28-37 \$1,600 + \$160 per student
 - d. Student enrollments 38-54 No additional pay
 - e. Student enrollments 55-64 \$3,200 + \$160 per student

III. Clarifying Points

- 1. If a "high-capacity" class is used as part of load, then the first 27 students will count toward load. Likewise, if the "high-capacity" class is to be used for six credits of load, then the first 54 students will count toward load.
- 2. "High-capacity" online classes taught for overload will count toward the maximum allowable overload as the equivalent of one traditional section. Example: A three credit hour class is taught as a "high-capacity" online class and 32 students are enrolled. The faculty member will be compensated \$2,400 and the class will count toward their maximum overload for the semester as three credits.
